Tax Rate Hearing
August 15, 2017

The Chillicothe R-II School Board held a Tax Rate Hearing on Tuesday, Aug. 15, 2017 at 6:15 p.m. at the Administrative Offices, 1020 Old Highway 36 west, City of Chillicothe, State of Missouri.

Members present: Mr. Turner, Mr. Jones, Mrs. Horsman, Mr. Thomas, Mrs. Chapman and Mr. Bone.

CALL TO ORDER

Mr. Bone called the Tax Rate Hearing to order at 6:15 p.m.

APPROVAL OF AGENDA

Mr. Turner asked for a motion regarding the agenda for the Tax Rate Hearing. Mr. Bone moved to approve the Tax Rate hearing agenda as presented. Mrs. Chapman second. All were in favor. Motion carries, 6-0.

SETTING OF 2017 TAX RATE & PUBLIC COMMENT

Dr. Barnes presented the proposed 2017 tax rate. He noted that the District's new assessed valuation is \$142,393,192 (an increase of 3.0 percent from the previous fiscal year). He recommended the Board set the District's 2017-18 Tax rate as follows:

- Fund 1 - \$3.6080
- Fund 2 - \$0.0000
- Fund 3 - \$0.9660
- Fund 4 - \$0.1200

Levy Total: - \$4.6940 per \$100 assessed valuation


SETTING OF 2017 TAX RATE

Mr. Turner asked if there were any questions or comments regarding the proposed tax rate. Seeing none, he asked for a motion regarding the proposed 2017 Tax Rate. Mr. Bone moved to approve the tax rate as follows: \$3.6080 for Fund 1, \$0.00 in Fund 2, \$0.9660 in Fund 3, and \$0.1200 in Fund 4 for a total tax levy of \$4.694. Mr. Jones second. All were in favor. Motion carries, 6-0.

Mr. Turner asked for a motion to adjourn. Mr. Thomas moved to adjourn the Tax Rate Hearing. Mrs. Horsman second. All were in favor. Motion carries. Meeting is adjourned.
